

TAXPAYER MAIL-IN APPLICATION FOR 2009 STICKERS & SHELLFISH PERMITS

Note: Beach Stickers, Transfer Station Stickers and Shellfish Permits are issued only to Taxpayers (resident and non-resident) of the Town of Eastham and their legal dependents. Please make sure all items required are mailed in with your request form. **We will be unable to process your request if documentation is missing.** At this time, we are only processing mail-in requests. **PLEASE NOTE:** The Sticker Office is currently **not** open for business. If you choose to purchase your stickers/permits in person, the Sticker Office (located at **555 Old Orchard Road**) will open in late May and you may do so then. If you have any questions, please call **508-240-5974**. After Memorial Day, please call the Sticker Office at **508-240-5976**. Thank you for using the mail-in sticker program!

When applying for your 2009 Stickers & Permits, the following must be included:

- The completed application form (found below).
- A copy of your current registration for each vehicle requesting a permit.
 - A. If your registration(s) reflects a leased vehicle, please send a copy of each registration and a copy from your lease agreement showing your name.
 - B. If your vehicle is leased/registered to a business, please send a copy of the registration, a copy of the lease, and a document linking you to the business (business card or letterhead).
- **Please note: Stickers are only issued to trustees' vehicles, not to beneficiaries' vehicles.**
- **Payment form is only accepted in a check or money order made payable to the Town of Eastham. This check or money order must be a separate check or money order from your taxes.**
- **A self-addressed stamped envelope. Without the envelope, your order will be held at the Sticker Office and won't be available for pick-up until the office opens in late May.**

Please Note: ***Mail your sticker application separate from your taxes.
 ***We do not start processing mail-ins until mid-April.
 ***Allow three (3) weeks for the processing of your mail-in.

- The 2008 Transfer Station Sticker and the 2008 Beach Sticker expire on June 30, 2009. New stickers, for both, will be required on July 1, 2009. The 2008 Shellfish Permit expires on May 31, 2009
